

Schueco UK Limited Anti-Slavery and Human Trafficking Statement - 2020

1. Opening Statement from Senior Management

Schueco UK Limited is committed to preventing acts of modern slavery and human trafficking from occurring within its business and supply chain, and imposes the same high standards on its suppliers. Peter Temprell, Managing Director of Schueco UK Limited and fellow directors are committed *to ensuring there is no slavery or trafficking within its supply chain.*

2. Structure of the Organisation

Schueco UK Limited is a UK subsidiary of a global firm which operates in the sale and distribution of aluminium steel and architectural systems related services. The immediate parent company of Schueco UK Limited is Schüco International KG, a company incorporated in Germany. Its ultimate parent undertaking and controlling party is Otto Fuchs Kommanditgesellschaft, a company incorporated in Germany. The company employs 4,750 people worldwide and has business operations in 80 countries.

In order to fulfil our business commitments we work with a range of suppliers and fabricators.

3. Policies

As part of our commitment to combating modern slavery, we have implemented the Modern Slavery Act Policy set out on our website.

We also make sure our suppliers are aware of our policies and adhere to the same high standards.

4. Due diligence

As part of our efforts to monitor and reduce the risk of slavery and human trafficking occurring within our supply chains, we have adopted the following due diligence procedures:-

- employees are encouraged and expected to report any concerns regarding slavery and human trafficking and management is expected to act upon them;
- risk assessments may be carried out for any part of the business or that of our suppliers which may be at risk from modern slavery so that we can focus our efforts on these areas;
- where appropriate the company may introduce suppliers pre-screening (e.g. as part of the tender process) and self-reporting for our suppliers on safeguarding controls; and
- where appropriate the company may introduce contractual provisions for the suppliers to confirm their adherence to the Modern Slavery Act and accept the company's right to audit their activities both routinely and, at times, of reasonable suspicion.

Our procedures are designed to:

- establish and assess areas of potential risk in our business and supply chains;
- monitor potential risk areas in our business and supply chains;
- reduce the risk of slavery and human trafficking occurring in our business and supply chains; and provide adequate protection for whistleblowers.

5. Risk and compliance

Schueco UK Limited regularly evaluates the nature and extent of its exposure to the risk of Modern Slavery occurring in its supply chain.

We do not consider that we operate in high risk sectors or locations because of contractual relationships with reputable and properly managed companies.

We ensure all our suppliers adhere to our *anti-slavery policy*. We do not tolerate slavery or human trafficking within our supply chain. For example, if we find evidence of a failure to comply with our *anti-slavery policies*, we will immediately seek to terminate our relationship with the relevant supplier or contractor.


6. Training

We educate our staff to recognise the risks of modern slavery and human trafficking in our business and supply chains. Through training programmes, employees are encouraged to identify and report any potential breaches of our policy. Employees are taught the benefits of stringent measures to tackle slavery and human trafficking, as well as the consequences of failing to eradicate such practices from business and supply chains.
